SUPPLEMENTARY REGULATIONS:

1. JURISDICTION: held under the National Sporting Code and Standing Regulations for Enduro's of the ACU the Southern Centre Enduro Regulations, these Supplementary Regulations and any final instructions that may be issued.
2. ELEGIBILITY: Open to registered Adult members of the Portsmouth Motor Cycle Racing Club, driving Solo, Sidecar Moto-Cross, Enduro, Trail, Trial and Quad Machinery.
3. **Numbers: To be displayed on the front of machine(side panels are optional)**
4. CLASSES: Championship / Expert / Clubman A /Clubman B / Sportsman,
5. TYRES: Optional, MOTOCROSS, ENDURO.
6. SCRUTINEERING: From 9.00am till 10.30am. No engines to be started earlier than 5 minutes before start of event.
7. START: Riders to leave at 1 minute intervals in class groups, DURATION: Three (3) hours.
8. COURSE: Approximately 6.75 miles in woodland with natural obstacles, All on private Land.
9. ENTRIES: Open 1st August and close on the day. To be made on form supplied and sent to the Secretary of the Meeting, with Entry fee **£30** with **Two A5** Stamped Addressed Envelopes. **Cheques made payable to P.M.C.R.C. Ltd. ENTRY FEE ON THE DAY £35**
10. **Proof of CLUB MEMBERSHIP must be shown at signing on.**
11. MEDICATION: You may be asked to take a drugs test, it is your responsibility to declare at signing on if you take Medication.
12. GENERAL: **ACU LICENCE TO BE SHOWN AT SIGNING ON.** Machines to comply with current noise limits. Power washers to be used only in designated areas. **Environmental matting to be supplied by riders in Parc Ferme Area.**
